#### **Usage:**

Apply a little quantity of cream (0,5-1 ml) in circular motions on clean and dry hands before work. Pay special attention to areas between fingers and fingernails. Apply cream on body and face if necessary. After work add some water and Riza Premium Handwash liquid soap, foam gently and rinse it off. Intense contaminants removal is provided by cleansing products of Riza series.

0,5-1 ml per use.

Every tube has a **first break control that guarantees the microbiological safety of the product and prevents vandal actions**.
