

Skin cleansing paste for removal of extra-heavy industrial contaminants «Riza Ultra Clean»

- **A specially selected complex of cleansing components provides intense contaminants removal, its nourishing components minimize solvents contact with skin;**

- Kaolin in composition **additionally absorbs contaminants**, enhancing the cleansing action
- **Riza Ultra Clean is a rich complex:**
 - **Castor oil** has a wound-healing, antiphlogistic, softening and antioxidant effect.
 - **Rice bran oil** has a moisturizing, regenerating and antioxidant effect, is recommended for dry and sensitive skin.
 - **Sunflower seeds oil** cleans the skin, has high nourishing quality, stimulates skin regeneration, smoothes it, makes it healthy, provides antioxidant and antiseptic effect;
 - **Olive oil** has a positive effect on the skin, softens it, regenerates, moisturizes and retains water.
 - **Safflower oil** smoothes and moisturizes;
 - **Natural essential oils** provide a unique perfume composition of Riza;

Usage:

Apply a little quantity of the paste (1-2 ml) on dirty hands and rub it thoroughly, paying special attention to the skin between fingers and around nails. Add a little of water and rub it again. Rinse it up. To continue work apply the protective cream of Riza series. Use the regenerating cream of Riza series at the end of working day.

Consumption for one use:

1-2 ml.

Packing features:

Every tube has a **first break control that guarantees the microbiological safety of the product and prevents vandal actions.**

Riza tubes have a **unique pleasant texture**, but moreover they bear a function **to assist workers** due to the **bold points texture on tube sides which help to improve grip.**
